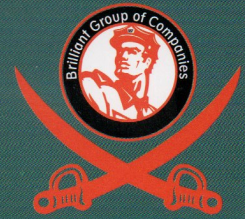

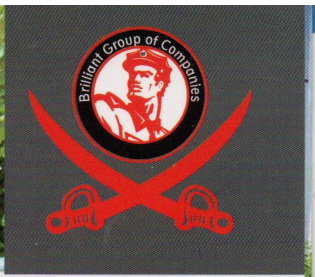
Brilliant Group of Companies offers the following advantages:
